

Castaways 2025 – Voter’s Prize

Terms and Conditions

Entrants who cast an online vote for their favourite artwork for the 2025 Castaways People’s Choice Awards will be given the opportunity to enter into a draw to win the \$500 Voter’s Prize. By participating, you agree to the following Terms and Conditions:

General Public Voting and Voter’s Prize Eligibility

- Entrants must be 18 years or older at the time of entry to be eligible for the Voter’s Prize.
- Entrants must be a resident of Western Australia.
- City employees and their immediate family are not eligible to participate.
- City contractors involved with the 2025 Castaways Sculpture Awards are not eligible to participate.
- Entry into the prize is free.
- Only one entry per person is permitted. Duplicate votes submitted under multiple names or email addresses will be disqualified.
- Voting for the People’s Choice Awards and entry into the Voter’s Prize draw closes at **5pm on Sunday 2 November 2025**, after this time no further entries will be permitted.
- There will be one prize winner selected by a random number generator.
- The winner will be notified no later than 14 November 2025 by the email provided on the People’s Choice Awards voting form. Invalid emails will result in disqualification and a new winner will be selected.
- If the winner does not respond within seven calendar days, the prize will be forfeited and a new winner will be selected.
- The winner will be required to complete and sign documents provided by the City to process the prize. Incomplete information or delays in returning the documentation will result in a delay of payment or non-payment.
- By entering the draw, entrants consent to the City collecting and using their personal information for the purposes of administering the prize draw and contacting the winner, in accordance with the City’s privacy policy.
- The City is not responsible for technical failures, lost or misdirected entries, or any issues outside its control that may interfere with the voting or draw process.
- The City reserves the right to modify or cancel the prize draw at any time if unforeseen circumstances arise that impact its fairness or integrity.

- The City reserves the right to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these Terms and Conditions.
- The \$500 Voter's Prize is non-transferable, non-exchangeable and not redeemable for cash or other prizes.

Castaways Finalist Artists and Schools

- Castaways 2025 finalist artists and participating schools are permitted to vote in the People's Choice Awards and may vote for their own artwork.
- Voting is strictly limited to one vote per person.
- Students under 18 years of age may vote for the People's Choice Awards but are not eligible to win the \$500 Voter's Prize.
- Finalist artists and representatives of participating schools are not eligible to win the \$500 Voter's Prize.
- Artists and schools are encouraged to promote their participation in the event, including via social media; however, all votes for the People's Choice Awards must be cast by individuals who have personally attended the exhibition in person.
- The following actions are strictly prohibited:
 - Coordinated mass voting campaigns
 - Automated voting methods
 - Vote incentivisation (e.g. offering rewards or inducements)
 - Submitting votes on behalf of others
 - Using false identities
 - Soliciting votes from individuals who have not experienced the exhibition in person are strictly prohibited.
- Any breach of these conditions will result in disqualification from the People's Choice Awards and may result in exclusion from future Castaways Sculpture Awards.
