

The City of Rockingham's Blender Bike is a stationary bike that has a blender attachment which is powered by the pedal-power of users. The Blender Bike can be used to produce fresh and nutritious drink by placing ingredients such as fruits, juice, vegetables, yoghurt and ice into the blender jar, then pedal to power the blender and mix the ingredients. The blender bike is a great way to engage people at events and promote healthy lifestyles.

The blender bike is available to community organisations, groups, schools, sporting clubs and businesses. Preference is given to community organisations and schools and/or users located within the City of Rockingham.

The blender bike is stored at Baldivis Indoor Sports Complex at 531 Eighty Road Road in Baldivis. Users are required to collect and return the bike at the booked times.

Applicable hire fees are charged as follows:

- **Commercial**
 - Any department, agency or instrumentality of the State or the Commonwealth or any statutory body;
 - Any company or body corporate other than an association incorporated under the Association Incorporations Act 1987; or
 - Any individual intending to use the hired Blender Bike for profit or gain.
- **Non-Commercial**
 - Any person or body other than a commercial hirer

Hire Fee:

- Non-commercial – no cost (free)
- Commercial - \$100 per day

Bond:

- Non-commercial - \$250.
- Commercial - \$250.

Please read and agree to the Terms and Conditions, complete the relevant Blender Bike booking application form and email it to baldivisindoorsc@rockingham.wa.gov.au or in person at the Baldivis Indoor Sports Complex.

The City of Rockingham has made the blender bike available to support your organisation, school or community group to encourage healthy fundraising and health promotion activities in the community. The City of Rockingham appreciates your cooperation and adherence to the Terms and Conditions of use to ensure the City can continue to provide this service.

Terms and Conditions

1. Basis of hire and use

- 1.1. All bookings are subject to the City of Rockingham local laws and regulations.
- 1.2. The equipment must only be used for its intended purpose as outlined in the first page.
- 1.3. The blender bike and/or its equipment cannot be used by another party without expressed written permission from the City of Rockingham
- 1.4. The hirer must comply with the City of Rockingham [Single Use Plastic and Balloons Policy](#).
- 1.5. The blender bike is not to be used in any way that misrepresents the City of Rockingham.
- 1.6. The hirer will arrange a suitable time to collect and return the blender bike to Baldivis Indoor Sports Complex and arrange suitable vehicle to transport the blender bike. The hirer will provide proof of identity (Driver's License) and will undertake an inventory check upon collection and return of the blender bike with a City officer.
- 1.7. The hirer will practice safe handling practices when moving, loading and unloading the blender bike.
- 1.8. The blender bike must be stored indoors overnight and not be used during wet weather conditions.
- 1.9. It is the responsibility of the hirer to ensure appropriate cleaning/food hygiene practices are applied during use.
- 1.10. The hirer is required to complete any relevant evaluation forms provided and return to the City of Rockingham when returning the blender bike.
- 1.11. The bike and associated equipment must be returned fully washed and in the same condition as when collected.
- 1.12. If the blender bike is returned to the City damaged or with pieces are missing, the borrower will be invoiced for the damage or costs to replace items.
- 1.13. If the blender bike is damaged and cannot be repaired, the borrower will be invoiced for the complete cost of replacing the blender bike. The cost is approximately \$4,800 (including bond fee).
- 1.14. The City of Rockingham must be notified immediately upon the hirer becoming aware of the loss, damage or theft of the hired equipment by contacting Baldivis Indoor Sports Complex on 9591 0840 or via to baldivisindoorsc@rockingham.wa.gov.au

2. Payment of bond and hire fees (including GST)

- 2.1. Hire fees must be paid in full to confirm the booking and the bond must be paid no later than 14 days before the booking

3. Refund of bond

- 3.1. The bond will be refunded by and electronic funds transfer, usually within two weeks from the date of the facility hire.
- 3.2. The bond will only be refunded to the individual / company that made the original bond payment, otherwise written confirmation will be required from the original payee
- 3.3. The following fees and charges may be deducted from the bond:
 - Additional Blender Bike hire time
 - Repairs to the Blender Bike
 - Additional cleaning
