- Three copies of a site plan drawn to scale (1:100 or 1:200) showing the location of the existing building envelope and proposed building envelope and boundary setbacks.
- Bushfire Attack Level (BAL) Assessment undertaken by a suitably qualified bushfire consultant. If the BAL is greater than BAL-Low, a report demonstrating compliance with the four Bushfire Protection Criteria of State Planning Policy 3.7 - Planning in Bushfire Prone Area.
- Tree Survey detailing the location of tree trunks and canopy and tree heights and diameters.
- Pro forma submissions from nearby and adjoining owners - optional (the City will undertake notification of neighbours when this has not been undertaken by the applicant).
- An electronic copy of the required information (provided on a USB or disc).
