Councillor Rae Cottam, a councillor for the City of Rockingham publicly apologise, as specified in paragraph 2, or failing compliance with paragraph 2, then paragraph 3 below shall apply. 2. At the ordinary council meeting first occurring after the expiration of 28 days from the date of service of this Order on her, Councillor Cottam shall: <ol style="list-style-type: none"> a. attend the relevant ordinary council meeting; b. ask the presiding person for his or her permission to address the meeting to make a public apology to the public; c. make the apology immediately after Public Question Time or during the Announcements part of the meeting, or at any other time when the meeting is open to the public, as the presiding person thinks fit; and d. address the Council and public as follows, without saying any introductory words before the address, and without making any comments or statement after the address: <p><i>“I advise this meeting that:</i></p> <ol style="list-style-type: none"> <i>i. (D22/156744)</p> <p>On 15 August 2023 advice was received from the Panel that a breach occurred.</p> <p>The Panel ordered Mayor Hamblin to make a public apology, pursuant to section 5.110(6)(b)(ii) of the Act:</p> <ol style="list-style-type: none"> 1. Mayor Deborah Hamblin (“Mayor Hamblin”), an elected member for the City of Rockingham, publicly apologise, as specified in paragraph 2 below, or failing compliance with paragraph 2, then paragraph 3 below. <p><u>PUBLIC APOLOGY</u></p> <ol style="list-style-type: none"> 2.
