A Word From the Mayor

The City of Rockingham is home to more than 140,000 people, and continues to grow at a rate well above the state average as more people move into the area to enjoy the many lifestyle benefits available.

Providing the facilities and services required by a growing population takes careful planning and prudent budgeting to ensure the construction of new facilities can occur along with the replacement of existing assets and buildings.

This year's budget strikes a balance between current realities and future needs, and is very mindful of the ongoing impact of inflation.

The budget is based on a rate increase of 3.9%, well below inflation and in line with Council's expectations to limit the inflationary pressure on ratepayers. This increase equates to \$1.65 per week for the average residence. However, due to Landgate's revaluation of all properties within the City this year, the adjustment to rates will not be consistent. Some ratepayers may see a greater or a lesser increase than others.

While there are many projects underway in the City, the major community-based infrastructure projects included in this budget are as follows (some may run over multiple years):

Aqua Jetty Stage 2	\$29.3m
Stan Twight Reserve clubroom extension	\$4.52m
Baldivis Outdoor Recreation Space	\$2.24m
Baldivis Sports Complex outdoor courts and pavilion	\$4.25m

We will also continue building and strengthening community connectedness through a range of popular free-to-attend events throughout the year.

As every householder knows, balancing the budget is a challenging task. It is for the City, too. Your rates are an essential component of the City's ability to meet the needs of our current and future residents, and on behalf of Council I thank you for your contribution.

I would like to thank all the Councillors and City Officers for delivering a budget that meets the needs of our growing community, while keeping the rate increase as low as possible in this time of high inflation.

Revaluation

Property valuations are adjusted by Landgate every three years for properties rated using the Gross Rental Value (GRV), and yearly for properties using the Unimproved Value (UV). 2023 is a revaluation year for both GRV and UV rated properties. Rates and Minimum Charges

The City of Rockingham will apply differential general rates and minimum payments for the 2023/2024 financial year as summarised in the following table:

Why Do We Have Differential Rates?

The City's rating strategy is to achieve rate revenue that meets the shortfall from other revenue sources and allows for the delivery of services and the creation of infrastructure. The City desires to levy rates that are more equitable across different types of properties, so we have implemented differential general rates which reflect the costs associated with service delivery across the different rating categories.

Objectives of the Differential Rates

Gross Rental Value (GRV) Properties

Properties rated on a GRV basis make up approximately 99.5% of the total rates levied and have been classified into the following rate categories.

GRV - Non-Residential

A differential rate of 9.052 cents in the dollar applies to Non-Residential Land.

"Non-Residential Land" means all land other than Residential Land.

The City has implemented a 13.86% differential rate on Non-Residential properties to assist in the cost of infrastructure and services specifically designed to support the Non-Residential sector.

GRV - Residential

A differential general rate of 7.95 cents in the dollar applies to Residential Land.

"Residential Land" means any land used, or designed, or adapted for use, for the purpose of a dwelling and includes vacant land within the Residential, Development, Rural, Special Rural, Special Residential, Commercial, District Town Centre, Primary Centre Waterfront Village, Primary Centre Urban Village, Primary Centre City Centre, Primary Centre City Living, Primary Centre Campus and Primary Centre Urban Living zones under the City of Rockingham Town Planning Scheme No. 2.

"Dwelling" has the meaning given to it in the City of Rockingham Town Planning Scheme No. 2.

The rate applied to GRV - Residential is the differential general rate used as the basis on which the other GRV rate categories are calculated.

Pensioner Rates Concession

Since 1 July 2016 the concession allowed to eligible pensioners on local government rates has been capped. The capped amount for 2023/2024 is \$750. Pensioners may also be eligible for a rebate of up to 50% of the current year's Emergency Services Levy and annual Water Corporation rates.



Seniors Rebates

Seniors Card holders may be entitled to claim a rebate of up to 25% of the current year's Emergency Services Levy, and up to \$100 of their rates. To find out more visit seniorcard.wa.gov.au

Emergency Services Levy

The Emergency Services Levy (ESL) is a State Government charge applied to all properties in Western Australia to share the cost of funding WA's essential fire and emergency services. The amount collected and the applicable rates and charging parameters are announced each year by the Minister for Emergency Services. The City does not charge this levy but is required to collect it on behalf of the State Government. For more information visit dfes.wa.gov.au



Spread your rates payments over weekly, fortnightly or monthly equal direct debit instalments calculated to pay the full rates amount before the end of each financial year. You can also Rate Smooth straight from your credit card at no extra cost.

How Do I Rate Smooth?

Complete the form included with the rates notice and return it to the City by 11 August 2023 in time for payments to begin on 18 August 2023. If the form is not received by this date, unfortunately Rates Smoothing will not be available.

Rates Smoothing will automatically continue for future years until you request it to be cancelled.
