### AG301

### AGRICULTURAL PRODUCTS ACT 1929

TABLE GRAPE GRADING CODE

Made by the Minister for Agriculture under section 3F.

### 1. Citation

This Code may be cited as the Table Grape Grading Code 2001.

### 2. Commencement

This Code comes into operation on the day of its publication in the Government Gazette.

### 3. Interpretation

In this Code-

"mature" means meeting the minimum standard of maturity approved by the Director General for the relevant variety, when tested in a manner approved by the Director General.

"grower organisation" means Table Grape Producers' Committee established under the Agricultural Produce Commission Act 1988.

### 4. Grades

- (1) Table grapes must be graded as—
  - (a) market grade; or
  - (b) undergrade.
- (2) Table grapes graded as market grade must be mature.
- (3) Table grapes graded as undergrade must not be sold.

### 5. Notification of minimum standard

Before the start of a season the Director General is to notify the grower organisation of the minimum standard of maturity approved by the Director General for each variety of table grapes for that season.

### **CEMETERIES ACT 1986**

### GERALDTON CEMETERY BOARD

By-law Relating to the Geraldton Public Cemetery.

Under the powers conferred by the Cemeteries Act 1986, the Geraldton Cemetery Board resolved on the 21 March 2001 to adopt the Model Local Law (Cemeteries) 1998 published in the *Government Gazette* on 12 May 1998 in relation to the Geraldton Public Cemetery, with such modifications as are here set out.

#### 1. Clause 1.1

After "the" insert "Geraldton Cemetery Board By-law 2001.".

### 2. Clause 1.3

Insert after "The following By - Law is repealed: - ", " The By-laws made by the Trustees of the Geraldton Cemetery Board under the provisions of the Cemeteries Act 1897, published in the *Government Gazette* on 23 October, 1969, with amendments."

### 3. Clauses 3.6 to 3.9 Inserted

Insert the following new clauses—

### "3.6 Fixing times for a Funeral

The time fixed for a funeral is at the discretion of the Board but subject to this By - law will be as near as possible to the time requested by the applicant.

### 3.7 Receipt of the Application for a Funeral

Where an application is received by the Board in accordance with clause 3.1 or 3.2, then subject to any other provision of this By - law, the Board shall—

- (a) fix a time for the funeral; and
- (b) prepare any grave that is required or reserve the venue for a cremation service as the case may be.

### 3.8 Times for Burials

A person shall not carry out a burial—

- (a) on a declared Public Holiday; or
- (b) at any time other than during the following days and hours—

Monday to Friday 8.00am to 4.00pm; Saturday 9.00am to 11.00am,

except with the written permission of the Board.".

### 3.9 Times for Cremations

A person shall not carry out a cremation—

- (a) on a declared Public Holiday; or
- (b) at any time other than during the following days and hours—

Monday to Thursday 8.00am to 4.00pm; Friday 8.00am to 2.00pm; Saturday 9.00am to 11.00am,

except with the written permission of the Board.".

### 4. Clauses 6.3 and 6.4 Inserted

Insert the following new clauses—

### **"6.3 Re-opening a Grave**

Subject to section 58 of the Cemeteries Act 1986, if for the purpose of re-opening a grave in the Cemetery the Board finds it necessary to remove a monument, edging, tiles, plants, grass, shrubs or other like matter from the grave, then the person applying for the re-opening of that grave shall bear the cost of the removal and any necessary reinstatement.

### 6.4 Opening a Coffin

A person shall not open a coffin in the cemetery unless—

- (a) the coffin is opened for the purposes of the exhumation of a dead body; or
- (b) that person has produced to the Board an order signed by the Commissioner of Police and the Board has approved the opening of that coffin; or
- (c) The Board has approved the opening of the coffin by that person as part of a religious ceremony.".

### 5. Clause 7.15

In subclause (1)—

- (a) Immediately after the paragraph designation, delete "not less than" and substitute "be of"; and
- (b) "the dimensions approved by the Board for the area in which the memorial plaque is to be placed.".

### 6. Second Schedule

- 6.1 Insert as the place and mail address for the payment of a penalty "Geraldton Cemetery Board, 130 Eastward Road, Geraldton".
- 6.2 Delete ", between the hours of 9am and 4.30pm Monday to Friday".

Health Act 1911

# **Health (Poultry Manure) Regulations 2001**

Made by the Governor in Executive Council under sections 199(21) and 343A(1) of the *Health Act 1911*.

### 1. Citation

These regulations may be cited as the *Health (Poultry Manure) Regulations 2001*.

# 2. Commencement

These regulations come into operation on 1 September 2001.

# 3. Interpretation

In these regulations —

- "approved" means approved by the Executive Director, Public Health;
- "commercially-derived", in relation to poultry manure, means poultry manure that is the result of a commercial poultry undertaking, including egg production through "layer" farming, or meat production through "broiler" farming;
- **"poultry"** means chickens, ducks, geese, emus, ostriches, turkeys, waterfowl, and any other birds bred or kept for commercial purposes (other than for the purpose of sale as pets);

- "process" means a process for the treatment of untreated poultry manure that is intended to prevent flies from breeding in the manure after treatment by that process;
- "untreated poultry manure" means poultry manure, whether or not mixed with other materials, that has not been subject to treatment by an approved process.

# 4. Regulations to operate as local laws

These regulations apply to the local government districts set out in the Table to this regulation as if they were local laws made under the Act.

# 5. Untreated poultry manure specified to be a "hazardous substance"

Under section 199(21) of the Act, untreated poultry manure is specified to be a "hazardous substance".

# 6. Storage, etc., of untreated poultry manure

- (1) A commercial producer of untreated poultry manure may store commercially-derived untreated poultry manure at the place of production, at any time.
- (2) A person undertaking an approved process in relation to untreated poultry manure may store commercially-derived untreated poultry manure at any time for the purposes of treating that manure.
- (3) A person may store, supply, sell, transport, or use commercially-derived untreated poultry manure at any time for the purposes of
  - (a) treating that manure by an approved process; or
  - (b) temporary storage of the manure at a landfill site that is subject to an appropriate licence under Part V of the *Environmental Protection Act 1986*.
- (4) A person may store, supply, sell, transport, or use commercially-derived untreated poultry manure during the months of May, June, July and August of any year, unless the Executive Director, Public Health by declaration excludes one or more of those months, or a part of one of those months, from this subregulation.

### 7. Declaration

A declaration by the Executive Director, Public Health under regulation 6(4) —

- (a) is to be published in the *Gazette*, and a newspaper circulating generally in the local government areas set out in regulation 4;
- (b) has effect from the day of its publication in the *Gazette*, or a day after the day of its publication in the *Gazette* as specified in the declaration; and
- (c) is to contain a brief explanation of the effect of the declaration and the consequences of a breach of regulation 8.

# 8. Offences

(1) Unless a person is specifically permitted to do so under regulation 6, a person shall not store commercially-derived untreated poultry manure.

Penalty: see regulation 9.

- (2) Unless a person is specifically permitted to do so under regulation 6(3) or 6(4), a person shall not supply commercially-derived untreated poultry manure.

  Penalty: see regulation 9.
- (3) Unless a person is specifically permitted to do so under regulation 6(3) or 6(4), a person shall not sell commercially-derived untreated poultry manure.

  Penalty: see regulation 9.
- (4) Unless a person is specifically permitted to do so under regulation 6(3) or 6(4), a person shall not transport commercially-derived untreated poultry manure.

  Penalty: see regulation 9.
- (5) Unless a person is specifically permitted to do so under regulation 6(3), 6(4) or 10, a person shall not use commercially-derived untreated poultry manure.

  Penalty: see regulation 9.

### 9. Penalty

The penalty for an offence under regulation 8 is —

- (a) in the case of a first offence a penalty which is not less than \$100 and not more than \$1 000;
- (b) in the case of a second offence a penalty which is not less than \$200 and not more than \$1 000;
- (c) in the case of a third or subsequent offence a penalty which is not less than \$500 and not more than \$1 000;
- (d) in the case of a continuing offence a daily penalty which is not more than \$100 and not less than \$50.

# 10. Transitional

At any time during the month of September 2001, a person may use untreated poultry manure on his or her property, if that manure was in storage on his or her property prior to 1 September 2001.

CITY OF ROCKINGHAM

### HEALTH AMENDMENT LOCAL LAWS 2001

Made by the Council of the City of Rockingham under section 342 of the *Health Act* 1911 in accordance with subdivision 2 of Part 3 of the *Local Government Act* 1995.

### 1. Citation

These local laws may be cited as the City of Rockingham Health Amendment Local Laws 2001.

### 2. Principal local laws




