

The below expression of interest (EOI) relates to the 2022 WA Tourism Awards, and the City's commitment to supporting local tourism businesses to enter nominations into relevant awards categories.

The City of Rockingham will cover the nomination fee (ranging between \$190 - \$550 depending on the category) for a local tourism business to submit a nomination into this year's awards.

Supporting local tourism businesses to enter nominations in the WA Tourism Awards supports key elements of the Tourist Destination Strategy 2019 – 2024, including:

- Destination marketing
  - Establish and promote Rockingham as a coastal and adventure destination which offers unique coastal facilities and scenery, as well as various outdoor adventure activities.
- Eco and adventure tourism
  - o Identify opportunities in the non-coastal areas of Rockingham which could be developed and promoted to enhance Rockingham's image as a tourist destination that caters for the needs of all.

  - c. Accepts no liability for any false or misleading information provided by the business in relation to the WA Tourism Award nomination and submission.
