City of Rockingham Requirements

City of Rockingham Health Services approves Family Day Care applications in the City. Applicants must ensure;

- They are caring for a maximum of seven (7) children (including their own children).
- If there is a pool on the property, the City will not approve a Family Day Care unless the pool is compliant with the Building Code of Australia and has passed an inspection from the Building Compliance Officer.
- The premises is adequately fenced.

Family Day Care facilities are also classed as 'food businesses' to which the following conditions apply;

- Operators are required to comply with the provisions of the Food Act 2008 and the Food Standards Code.
- Kitchen to have a double bowl sink with liquid soap and paper towels available.
- Stored food is to be protected from contamination and stored at correct temperatures.
- Kitchen to be maintained in a clean and tidy condition.

Application Forms and Fees

Applications to the City's Health Services to include the following two (2) documents:-

- 1. Family Day Care Application Form and fee of **\$55.00**.
- 2. Application for a Certificate of Registration / Notification Form (for a food business) and fee of \$30.00.

Please note

- Annual food premises fees are waived for Family Day Care premises.
- An Environmental Health Officer will do a final inspection of your premises for approval.
