

The following information is provided to give requirements on acceptance of asbestos at Millar Road Landfill.

Non-commercial Quantities

- All asbestos must be double-wrapped in a minimum of 0.2mm polyethylene plastic and sealed with 30mm minimum width heavy duty cloth pressure sensitive tape (eg gaffer or duct tape). Cello, electrical or paper-backing tapes are not acceptable. Alternatively asbestos may be contained in a fully sealed air tight container which must be disposed of with the asbestos.
- All wrapped asbestos must be clearly marked with the words “*Caution Asbestos*” at least 50mm high writing.
- Wrapped asbestos must be hand unloaded by the customer. As such, each wrapped asbestos package must not exceed a two-person lift.
- Tipping or dropping of asbestos packages from vehicles is strictly prohibited.
- Unwrapping/opening of asbestos packages on site is strictly prohibited.
- Torn or damaged plastic wrap or containers will be rejected.
- Vehicles may dispose of up to 1.5 cubic metres of asbestos with a City of Rockingham tip pass or on approved Transfer Station entry fees. Vehicles carrying more than 1.5 cubic metres of asbestos will incur higher entry fees.

Commercial Quantities

- All asbestos must be double-wrapped in a minimum of 0.2mm polyethylene plastic and sealed with a minimum width of 30mm heavy duty cloth pressure sensitive tape (eg gaffer or duct tape). Cello, electrical or paper-backing tapes are not acceptable. Alternatively asbestos may be contained in a fully sealed air tight container which must be disposed of with the asbestos.
- Commercial loads will not be accepted in skip bins or tip trucks.
- All asbestos received must use a hook truck with modified technique or a hiab. Asbestos must be able to be placed in final location by single lift by the customer.
- All asbestos-contaminated materials, eg soils or other loose materials, must be pre-approved. Customers must complete the Waste Application Form available on the City’s website prior to booking. Information will be provided when booking to meet pre-approval requirements.
- Unwrapping/opening of packages on site is strictly prohibited.

- Torn or damaged plastic wrap or containers will be rejected.

Other Information

- 24 hours notice must be given to the facility prior to disposal by calling 08 9528 0333. Please call during business hours Monday to Friday, 8:00am to 4:30pm to book. Bookings are available Monday to Sunday, 7:30am to 3:00pm (not between 12:00pm to 1:00pm). Online bookings may be made via the City's website [Hazardous household substances - City of Rockingham](#)
- On arrival at Millar Road Landfill Customers must follow the directions of staff at all times. **Staff reserve the right to refuse entry or disposal of asbestos should they determine the asbestos is not safe.**
