HEALTH LOCAL LAWS 2007

Health Act 1911

Health Local Laws 2007

Made by the Governor in Executive Council under section 343B of the Act.

1. Citation

These local laws are the *Health Local Laws 2007*.

2. Meaning of Health Local Laws

In these local laws —

“**Health Local Laws**” means the local laws made by a local government under section 342 of the *Health Act 1911*.

3. Health Local Laws relating to storage of food amended

The Health Local Laws of a local government listed in Schedule 1 are amended by deleting the provision listed in column 2 of the Schedule for that local government and inserting instead the following provision with the same designation as the deleted provision —

“

A person must not store, or allow to be stored, on any premises, any food, refuse or other waste matter unless it is contained in a rodent proof receptacle or compartment.

”.

4. Health Local Laws relating to limitation of liability amended

- (1) The Health Local Laws of a local government listed in Schedule 1 are amended by deleting each provision listed in column 3 of the Schedule for that local government and inserting instead the following provision with the same designation as the deleted provision —

“

The local government is not liable to pay compensation or damages of any kind to the person referred to in subsection (1) in relation to any action taken by the local government under this section, other than compensation or damages for loss or damage suffered because the local government acted negligently or in breach of duty.

”

- (2) The Health Local Laws of a local government listed in Schedule 1 are amended by deleting the provision listed in column 4 of the Schedule for that local government and inserting instead the following provision with the same designation as the deleted provision —

“

The local government is not liable to pay compensation or damages of any kind to the owner or occupier of premises in relation to any action taken by the local government or any of its staff under this section, other than compensation or damages for loss or damage suffered because the local government or any of its staff acted negligently or in breach of duty.

”

- (3) The Health Local Laws of a local government listed in Schedule 1 are amended by deleting each provision listed in column 5 of the Schedule for that local government and

inserting instead the following provision with the same designation as the deleted provision —

“

The local government is not liable to pay compensation or damages of any kind to the person referred to in subclause (1) in relation to any action taken by the local government under this clause, other than compensation or damages for loss or damage suffered because the local government acted negligently or in breach of duty.

”

- (4) The Health Local Laws of a local government listed in Schedule 1 are amended by deleting each provision listed in column 6 of the Schedule for that local government and inserting instead the following provision with the same designation as the deleted provision —

“

The local government is not liable to pay compensation or damages of any kind to the owner or occupier of premises in relation to any action taken by the local government or any of its staff under this clause, other than compensation or damages for loss or damage suffered because the local government or any of its staff acted negligently or in breach of duty.

”

- (5) The Shire of Busselton Health Local Laws are amended by repealing section 3(5)(c) and inserting instead —

“

- (c) The local government is not liable to pay compensation or damages of any kind to the person referred to in paragraph (a) in relation to any action taken by the local government under these local laws, other than compensation or damages for loss or damage suffered because

the local government acted negligently or in breach of duty.

”

- (6) The Town of Cambridge Health Local Laws are amended by repealing clause 5.2(4) and inserting instead —

“

- (4) The local government is not liable to pay compensation or damages to the permit holder for any disruption to business or loss arising from the local government taking any action referred to in subclause (1) or (2), other than compensation or damages for loss or damage suffered because the local government acted negligently or in breach of duty; and all rights and privileges granted by the permit shall be suspended in accordance with clause 3.11(2).

”

- (7) The City of Cockburn Health Local Laws are amended by repealing section 4(5) and inserting instead —

“

- (5) The local government is not liable to pay compensation or damages of any kind to the person referred to in subsection (4)(a) in relation to any action taken by the local government under this section, other than compensation or damages for loss or damage suffered because the local government acted negligently or in breach of duty.

”

- (8) The Town of Cottesloe Health Local Laws are amended by repealing section 3(5)(c) and inserting instead —

“

- (c) The local government is not liable to pay compensation or damages of any kind to the person referred to in paragraph (a) in relation to

any action taken by the local government under these local laws, other than compensation or damages for loss or damage suffered because the local government acted negligently or in breach of duty.
